Suit for declaration to the effect that the entry of name of plaintiff No. 3 mentioned as Manan in his Birth Certificate issued by defendant NO. 3 against Registration No. 8093 dated 11.10.2010 has become obsolete, redundant and superfluous because, after being adopted by plaintiffs No. 1 and 2 from his biological mother i.e. defendant No. 2 vide duly registered adoption Deed no. 415 dated 22.02.2023, the name of plaintiff no. 3 was changed from Manan to a new name Maahir and as such the name of plaintiff no. 3 is liable to be corrected in his aforesaid Birth Certificate from Manan to Maahir for all intent and purposes and simultaneously for further declaration to the effect that on the basis of aforesaid validly executed and registered Adoption Deed, vide which plaintiff No. 3 has been taken in adoption by plaintiffs no. 1 and 2 from defendant no. 2 being biological mother, the plaintiff no. 3 is now entitled to get the names of plaintiffs no. 1 and 2 entered and recorded as his adoptive parents in his birth certificate issued by defendant no. 3 against registration no. 8093 dated 11.10.2010 and in all other records of his identity, testimonials etc. for all intent and purposes for all times to come, and as such, the defendant no. 3 is liable to correct its record and issue a fresh birth certificate to plaintiff no. 3 by correcting the name of plaintiff no. 3 from Manan to Maahir and also by adding the name of plaintiffs no. 1 and 2 as his adoptive parents, with the consequential relief in the nature of mandatory injunction issuing directions to the defendant no. 3 to correct its record and issue a fresh birth certificate to the plaintiff no. 3 by correcting his name from Manan to Maahir and also by adding the names of plaintiffs no. 1 and 2 as his adoptive parents at the earliest on the basis of oral and documentary evidence of all kinds.
