Jarnail Singh Vs. Krishan

Suit for declaration to the effect that the land measuring 83K-14M CNR comprised in knewat no. 369 khatauni no. 545 to 549 as per jamabandi 001097-2018 for the year 2011-12 now comprised in knewat no. 406//369 khatauni no. 570 to 574, khasra no. 105//13 of 7-4, 14/1 of 7-0, 166//19/2 of 2-4, Next Date:- 16-03-2020 21 of 8-0, 167//14 of 1-7, 16 of 8-0, 17 of 8-0, 24 of 8-0, 25 of 8-0, 179//4 of 7-7, 5 of 7-7, 166/120 of 8-0, 179/17/1 of 3-2, 240// of 0-3, as per jamabandi for the year 2016-17 situated at Kheri Jalab, Tehsil Narnaund, now Tehsil Kheri Jalab, Distt. Hisar, is joint property of the plaintiffs, performa defendant and defendant no. 1 to 25 being cosharer and the plaintiffs and performa defendant are owner in possession to the extent of 80/837 share, out of the land measuring 83K-14M, as the same has not been partitioned at site by meats and bounds and the plaintiff and performa defendants are owner in possession at site of khasra no. 166//20 of 8-0, from dated 22-01-1996, on the day when the defendant no. 1 sold out land measuring 8K-0M to the plaintiffs and performa defendants vide registered sale deed no. 600 dated 22-01-1996 registered with Sub-Registrar Narnaund, Distt. Hisar and also having specific possession over this khasra number as co-sharer and further the impugned order passed in partition application bearing no. 26/31-NT dated 17-02-2016 alleged to be decided on dated 07-09-2017 by the defendant no. 28 and 29, titled as Krishan V/S Teka etc. dated 28-02-2016, 18-07-2016, 30-01-2017, 28-02-2017, 14-03-2017, 21-03-2017, 20-04-2017, 09-05-2017, 18-07-2017, 03-08-2017, 10-08-2017, and 07-09-2017, respectively, by which mode of partition was prepared and accepted, Naksha Ka, Kha, Ga, and Sanand Takshim, were called and prepared I issued in the absence of plaintiffs and on the basis of alleged instrument of partition dated 07-09-2017, execution petition no. 31-NT, of 2017 alleged to be filed by defendant no. 1, issuance of warrant of possession for dated 18-12-2017 by defendant no. 29 resultant alleged rapat no. 111 dated 19-12-2017, alleged mutation no. 3843 dated 16-01-2018 and further revenue record showing the land in dispute as partitioned, are illegal, arbitrary, against the provision of Punjab Land Revenue Act., result of promptness, without following the due process of law, against the pleading of the parties of partition application, null and void, nonest, nullity, void abinitio, without jurisdiction, against the principal of natural justice, against site, without any legal authority, against law and facts, mere paper transactions, come in existence secretly, result of collusion between the defendant no. 1 and 28 to 31, with out providing opportunity of being heard to the plaintiffs and the same are liable to be set aside, cancelled, corrected and are not sustainable in the eye of law, having no binding effect up on the rights of the plaintiffs and further suit for injunction prohibitory to the effect that the defendants no. 1 to 26 be restrained from causing any interference into the peaceful possession of the plaintiffs, dispossessing them from the land bearing khasra no. 166//20 of 8-0, from alienating, transferring, mortgaging, gifting, creating any charge, changing the nature of suit land, to cause damage to existing crop of mustered, which has been cultivated recently after harvesting the crop of Millet at site, till the land in dispute is not partitioned at site by meats and bounds, forever. On the basis of oral and documentary evidence of all kinds. Under order 7 rule 1 and 2 CPC.
