Suit for Declaration to the effect that Shri Rattan Parshad son of Shri Vishnu Parshad, resident of Surya Nagar, Hisar who was husband of the plaintiff No. 1 and father of the plaintiff No. 2 has not been heard and seen since 21.10.2012 that is for more than seven years by the persons who would have naturally heard and seen of him if he had been alive and as such he be deem to have died a civil death in view of the provisions contained in Section 108 of the Indian Evidence Act, 1872 and Shri Rattan Parshad was posted as Beldar in the office of Executive Engineer, Public Health Division No. 2, Hisar and whole service benefits of Shri Rattan Parshad, Beldar as plaintiffs are legally entitled to get the whole service benefits and other moveable and immoveable properties being legal heirs and successors of Shri Rattan Parshad, Beldar and are also entitled for inheritance of the properties and further declaration to the effect that the office order dated 17.03.2017 passed by the defendants No. 1 and 2 is wrong, illegal, arbitrarily, against law and is liable to be set aside vide which the services of Shri Rattan Parshad, Beldar has been dismissed from services of Shri Rattan Parshad, Beldar has been dismissed from services only on the absent ground with the consequential relief of mandatory injunction directing the defendants No. 1 and 2 to withdraw the impugned order dated 17.03.2017 and release the whole services benefits of Shri Rattan Parshad, Beldar, Payable to the legal heirs of deceased employee in death case during service and also the benefits provided under ex-gratia scheme to the plaintiffs on the basis of evidence of all kind.


