Suit for declaration to the effect that plaintiffs are owners in possession of 101/3526 share out of 2/27 share comprised in khewat no. 125/122 khatoni No. 179 to 182 out of total land 176 kanal 6 marla as per jamabandi for the year 1998- 99 situated at village Satrod Khass Tehsil and District Hisar and the revenue record is liable to be corrected in favour of plaintiffs as per their entitlement on the basis of their title and in consequential relief to the effect that defendants no. 1 to 3 be restrained to interfere into the possession of the plaintiffs qua remaining land and further be restrained to alienate the suit property in any manner on the basis of wrong revenue record and for the mandatory injunction to the effect that defendants no. 4 to 6 be restrained to release the compensation amount of the acquired suit land to defendants no. 1 to 3 and further the compensation amount released by defendants no. 4 to 6 in favour of defendants no. 1 to 3 beyond their entitled be recovered from them and be paid to plaintiffs as per their entitlement qua acquired land of their share alongwith interest at the rate of 18 percent per annum from the date of receipt till its realization and further the revenue entries regarding remaining land is liable to be corrected in favour of plaintiffs as owners in possession as per their respective share
