Appeal to modify the judgment and decree both dated 22.02.2017 passed by Sh. Vivek Chaudhary,
Civil Judge(Jr. Div.), Narwana, in Civil Suit no. 182 of 27.07.2012, ID No. CS 815-2013 whereby the
suit of the plaintiff/respondent No. 1 for declaration and permanent injunction has been partly decreed
with out costs to the effect that plaintiff is owner in possession to the extent of 1/8 share in the suit
property and sale deed no. 7706 dated 02.03.2012 is void to the extent of 1/8 share of plaintiff.
Consequently the defendant no. 1 is restrained from alienating the share of plaintiff in the suit property
and also restrained from making any construction without partition.

To set aside the judgment and decree dated 22.02.2017 of the Ld. lower court and to accept the appeal
of the appellant/defendant no. 1 with costs and to dismissed the suit of the plaintiff/respondent no. 1
