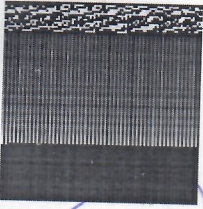

Suit for declaration to the effect that the plaintiff nos. 1 to 7 are owners in possession, in equal shares, of land measuring 04 kanals 00 marlas being 80/2240 share of land measuring 112 kanals 0 marlas comprised in square no. 83 killa nos. 6 to 8(24-0), 13-14-17-18-28(40-0), 24(8-0), Square no. 107 killa nos. 2-4-7-8(32-0), square no. 83 killa Nos. 15-16(16-0), and they are in exclusive possession of the land comprised in square no. 83 killa no. 6 min(3-3), 15 min(0-17), in lieu of the above said share in the total land, situated in village Sukhchain, Tehsil Kalanwali, District Sirsa, vide sale deed No.329 dated 17/5/85, registered in the office of Sub Registrar, Kalanwali, District Sirsa, as per the Jamabandi 1980-81 having purchased the same from Dhan Singh (now deceased) son of Bhag Singh, (father of the present defendants nos.1 to 3) and vide mutation No.4898 dated 15/05/1986 entered and sanctioned on the basis of the above said sale deed, and they are entitled to get themselves so recorded in the revenue record and in other government record, and the entries in the revenue record showing the position contrary to it, are wrong and incorrect, as the above said mutation No. 4898 was not incorporated in the subsequent Jamabandis and aforesaid Dhan Singh remained recorded as owner of the land which was sold by him to the plaintiffs vide aforesaid sale deed No.329 dated 17.5.1985, and further the mutation No.6168 dated 28.06.2005 regarding inheritance of aforesaid Dhan Singh is also wrong and illegal and is not binding on the rights of the plaintiffs, and also for declaration to the effect that the sale deed No.2841 dated 24/2/2006 regarding sale of land measuring 04 kanals being 80/3466 share of land measuring 173 kanals 6 marlas effected by defendant no.1 Gurjant Singh, in favour of Pritam Singh, defendant no.4, and the mutation No.6232 dated 27.4.2006 entered and sanctioned on the basis of this sale deed, and further the sale deed no. 1270 dated 5/7/2017 regarding sale of land measuring 04 kanals being 40/1733 share of land measuring 173 kanals 06 marlas by defendant no.2 Phalgu Singh, in favour of Kulwinder Kaur, defendant no.5, and mutation No.7182 dated 13/2/2018 entered and sanctioned on the basis of this sale deed and further the sale deed No. 914 dated 21.5.2018 regarding sale of land measuring 9 kanal 16 marla 3 sarsai (including the land in suit) by defendant no.1 Gurjant Singh in favour of defendant no.6 Sukhjinder Kaur and mutation No. 7240 dated 31.5.2018 sanctioned on the basis of this sale deed and the sale deed No. 2153 dated 4/7/2018 regarding sale of land measuring 7 kanals 6 marlas and 5 sarsai (including the suit land) effected by defendant no.2 Phalgu Singh in favour of defendant no.5 Kulwinder Kaur and mutation No. 7254 dated 12.07.2018 entered and sanctioned on the basis of this sale deed, and further the sale deed No.2973 dated 23.8.2018 regarding sale of land measuring 4 kanals 18 marlas 4 sarsai (including the suit land)effected by defendant no.3 Gurmail Kaur in favour of defendant no.6 Sukhjinder Kaur and mutation No.7270 dated 10/9/2018 sanctioned on the basis of this sale deed, are wrong, illegal, against law and facts and it is the result of collusion between these defendants as the defendants/vendors of the land, subject matter of these sale deeds, were not the owners in possession of this land and the defendants/vendees had full knowledge of this fact and as such, the aforesaid impugned sale deeds and the impugned mutations are liable to be set-aside and further entries in the revenue record i.e. the Jamabandis etc. made on the basis of the above said impugned mutations are wrong and illegal and these wrong entries are not binding on the rights of plaintiff, and also for Mandatory Injunction directing the defendant no.8 to make necessary correction in the revenue record in respect of the land in suit measuring 04 kanal 0 marla, as detailed above, in favour of the plaintiffs, recording the plaintiffs

as owners in possession of the land in suit, and as a consequential relief for injunction restraining the private defendants nos. 1 to 6 from causing interference, forcibly and illegally, into the lawful and peaceful possession of the plaintiff on the aforesaid land and also restraining them from selling or alienating the aforesaid land, to any one, on the basis of the impugned sale deeds and mutations and wrong entries in the revenue record, and from creating any type of bar, or encumbrance etc. on this land, till the final decision of this suit, and for grant of any other relief to which the plaintiff may be found entitled to, in view of the facts and circumstances of the case in hand, on the basis of evidence of every kind oral and documentary.

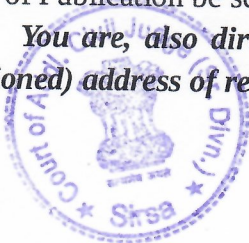
