Suit for declaration to the effect that the plaintiffs Nos. 1 to 6 have become the owners in possession of land measuring 145 kanals 14 marlas comprised in square no.23 killa no. 23/2(1-7), 19(8-0), 20(6-12), 21(7-4), 22(8-0) square no. 24 killa no. 16(7-7), 17(7-7), 24(8-0), 25(8-0) square no. 28 killa no. 4 to 6(24-0), square no. 29 killa no. 1(7-4), 2(8-0), 3(8-0), 6/1(8-0), 7/1(4-2), 7/3(1-17), 8/1(7-9), 8/3(0-1), 9(8-0), 10(7-4), situated in village Kheri, Tehsil and District Sirsa, as entered in khewat No.33 Min khatuni No.142, as per the latest Jamabandi 2011-2012, read with Mutation Nos. 1066,1088,1095,1104,1144 and 1231, having acquired the proprietary rights and occupancy rights in the aforesaid land, under the provisions of Section 5(1)(a) Section 2 of Punjab Tenancy Act, 1887 as amended upto date, read with the provisions of The Punjab Occupancy Tenants (Vesting of proprietary Rights), Act, 1952 (as applicable in Haryana) being in possession of this land for the last more than 100 years (more than two generations in the male line of descent) continuously and regularly till today (including the possession of their predecessors in interest), under the defendants and their predecessors in interest, without payment of any rent etc. to the recorded owners in any form, beyond the amount of the land revenue thereof and the rates and cesses for the time being



chargeable thereon, in respect of this land and the revenue record showing the defendants to be the owners and the plaintiffs to be in cultivating possession of the suit land as Gair Marusian are, therefore, wrong, illegal, null and void, against law and facts and as such, liable to be corrected and changed accordingly in favour of the plaintiffs declaring them as owners in possession of this land, in view of the provisions of the above said law, and as a consequential relief for permanent injunction restraining the defendants from interfering into the lawful possession of the plaintiffs over the suit land and also from dispossessing or ousting the plaintiffs from the possession of the suit land, and from alienating, transferring or selling the above said land to any one, in any manner, on the basis of evidence of every kindoral and documentary
