suit for declaration to the effect that the judgement and decree dated 27.07.2016 passed by the court of Smt. Anuradha Id. Civil Judge(Jr. Div) Sirsa passed in civil suit titled as Sandeep lamba vs Nauran Lal bearing civil suit no. 505 of 2014, vide which the suit for possession through specific performance of the contract dated 04.12.2013 shown to have been executed by the defendant no. 1 in favour of the defendant no. 2 and then the defendant no. 1 obtained the judgement and decree dated 27.07.2016 thus the same is quite wrong incorrect against law against facts, based on collusion in between the defendants just to defeat valuable right of recovery of loan amount payable by the defendant no. 2 to the plaintiff/bank being the loaner of the defendant no. 2 and as such the impugned judgement and decree dated 27.07.2016 is outcome of the big fraud committed by the defendant misrepresentation illegal, unjust, improper and violation of mandatory provisions of law, justice, equity, and fair play and also in violation of principles of natural justice result of concealment of facts, undue influence as such of the same are liable to be set aside and the plaintiff reserve his right to seek the right of recovery of the due amount of loan alongwith upto date interest thereon with consequential relief of permanent injunction restraining the defendant no. 1 from alienating/transferring or creating any charge or lien over the suit land measuring 17 kanal 15 marlas as detailed and described in the opening para of the judgement as well as jamabandi for the year 2007/2008 find mentioning the rapat of mortgage of the said land in favour of the plaintiff bank against the loan amount already taken by the defendant no. 2 and also restraining the defendants from doing any act qua the said land, which may amount to effect of legal right of the plaintiff bank and also restraining the defendant no. 3 from making the registration of any document pertaining to the suit land in favour of the defendnat no. 2 or anybody else on th basis of impugned judgement and decree and also for the relief of mandatory injunction to the defendant no. 3 for the correction of the revenue record in respect of the said land to the extent of suit land under the mortgage with the plaintiff bank on the basis of evidence of every kind oral and documentary.
