Particular of Claim :- Suit for declaration to the effect that the plaintiff no.1 is co-sharer to the extent of 1/5 share and the plaintiff no.2 and defendant no.5 are co-sharer to the extent of 1/5 share and the plaintiff no.3 and defendants no.7-8 are co-sharer to the extent of 2/5 share and the defendant no.6 is co-sharer to the extent of 1/5 share out of the land
