Sirsa, vide Jamabandi for the year 2016-2017 as the plaintiffs are the only legal heirs of the deceased Chanan alias Channan and the the deceased Nikku Ram or the defendants being the legal heirs of the deceased Nikku Ram have accrued no right title or interest over the suit land in any manner, because Nikku Ram has been adopted by Shri Bhura Ram and his wife since his child hood and as such Nikku Ram had been de-rooted from the succession of deceased father Channan alias Chanan..

B. Further declaration that the revenue record pertaining the suit lands existing and continuing in the name of the deceased Nikku Ram showing him as son of Channan alias Chanan are quite wrong, against the provisions of Hindu adoption and Maintenance Act and also against the law of Succession, as after adoption of Nikku Ram by Shri Bhura Ram, said Nikku Ram had left with no right, title or interest or any kind of succession right out of the estate of Chanan alias Channan and as such the revenue entries /revenue records shown in the name of Nikku Ram
