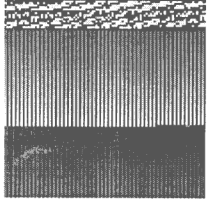

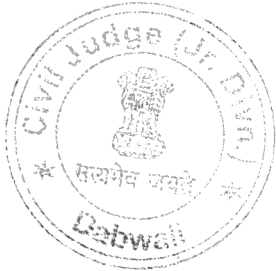

No. 816 Killa no. 3(8-0), 4(8-0), 5(8-0), 6(8-0), 7(8-0), 8(8-0), 13(8-0), 14(8-0), 15(8-0), 16(8-0), 17(8-0), 18(8-0), 23(8-0), 24(8-0), 25(8-0), vide fard Jamabandi for the year 2011-12, situated within the revenue estate of village Chautala, Tehsil Dabwali, District Sirsa, but the entries in the column of cultivation showing Aad Ram son of Bhagwana, resident of village Chandralia, Tehsil and District Sri Ganganagar to be in possession of the suit land as Gair Marusi, are wrong, against law and facts, null and void, void abinitio, ineffective and inoperative upon the rights of the plaintiffs and performa defendants and hence the aforesaid entry is liable to be corrected in favour of the plaintiffs and performa defendants as they are in cultivating possession of the suit land on the basis of evidence, oral as well as documentary of all kinds.

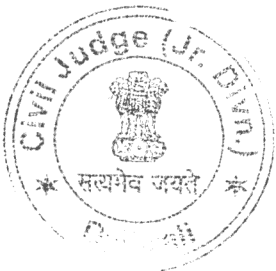
