Suit for Declaration to the effect that the plaintiff No. 1 is the owner in possession of 7/10th share and plaintiff No. 2 is the owner in possession of 1/10th share and the defendants No. 2 and 3 are the owners in possession of 2/10th share i.e. 1/10th share each of the flat/house Ground and premises bearing Old No. 7, New No. 17, Rajarathinan Street, Kilpauk, Madara -10, comprised in Sr. No. 273, RS No. 151/1(part) now R.S. No. 151/30 of block no. 12, CC No. 619 measuring an extent of 5 grounds 1365 Sq. feet, bounded as on North Premises bearing No. 7, Landons Road, owned by Ommen, West No. 16, Rajarathinan street owned by Sundram Pillai, South Rajarathinan street, East No. 18 Rajarathinan street, owned by Shri Bala Krishanan, within the registration District of Madras and Registration Sub District of West Madras. Ganga Ram the father of plaintiffs and subsequently after the death of Smt. Kamla Devi and the Government records as well as Municipal records, showing the Ganga Ram to be the owner in possession of the above said property is wrong and incorrect and the plaintiffs and the defendants No. 2 and 3 are entitled to be recorded as owners of the above said properties in all official records on the basis of inheritance of Sh. Ganga Ram in favour of the plaintiff and the defendants No. 2 and 3, as per the share mentioned above, on the basis of evidence of every description oral and documentary

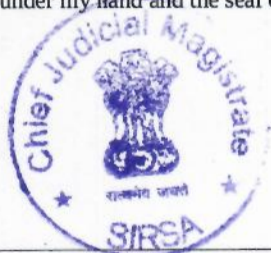
