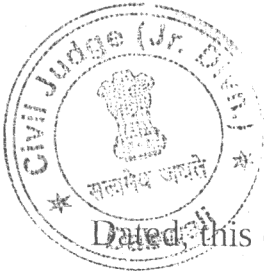

Particular of Claim :- Suit for Declaration to the effect that the plaintiffs are entitled to get right of occupancy tenant in equal share regarding the land comprised in Khewat no.150 khata no.413 kitta 5 area measuring 29 kanal 12 marlas and in Khewat no.213 khata no.416 area measuring 29 kanal 12 marlas and the defendant no.1 is entitled to get the right of occupancy tenant to the extent of 1/4 share and the defendants no.2-3 are entitled to get the right of occupancy tenant to the extent of 2/4 share and the defendants

no.4-5 are entitled to get the right of occupancy tenant to the extent of 1/4 share of the land comprised in Khewat no.150 khata no.414 area measuring 20 kanal 17 marlas and in Khewat no.150 khata no.417 kittas 3 area measuring 20 kanal 17 marlas, vide fard jamabandi for the year 2011-2012 situated at village Banwala Tehsil Kalanwali Distt.
