### **Particular of Claim :**

Suit for declaration to the effect that order dated 13.1.2016, passed by the court of Naib Tehsildar with the powers of Assistant Collector, Ist Grade, Nathusari Chopta (Sirsa), in case NO.8-NT/Partition, titled as Rameshwar and others Vs Sardari and others, vide which the learned Assistant Collector has confirmed the Naksha Bey and ordered for issuance of Sanad Takseem (Instrument of Partition) in respect of land measuring 50 kanal 4 marlas, comprising in Khewat No.231, Khatuni No.319, Kittas 7, 444 kanal 6 marlas, comprising in Khewat No.232, Khatuni No.320 to 324, and Khewat No.233, Khatuni No.325 to 330, and 384 kanal 12 marlas, comprising in Khewat No.773, Khatuni No.1034 to 1036, Kittas 57, situated within the revenue estate of village Jodhkan, Tehsil and District Sirsa, as per jamabandi for the year 2001-02 and thereby allotted respective lands to the plaintiffs and defendants, and also Instrument of Partition dated 26.4.2016, issued by the Id. Assistant Collector, Ist Grade, Nathusari Chopta (Sirsa) whereby the learned Assistant Collector, Ist Grade, has confirmed the partition of the suit land, and Mutation No.7574 entered on the basis of above impugned order dated 13.1.2016 and sanctioned on 18.9.2016, are wrong, against law, against facts, illegal, unlawful, void ab-initio, violative of mandatory provisions of law, equity and fair play and also violative of principles of natural justice, ineffective and inoperative qua the rights of the plaintiffs and as such, the same are liable to be set-aside and thereby allotting land along with tubewell, dhani, trees which were continuing in the possession of the plaintiffs, and as a consequential relief for permanent injunction, restraining the defendants from either alienating or transferring in any manner, whatsoever or creating any charge over any part of the suit land on the basis of mutation no.7574, and also form interfering into the lawful possession of the plaintiffs over the suit land, on the basis of evidence of every description, oral as well as documentary.
