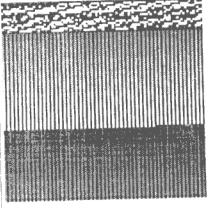

Particular of Claim :- Suit for declaration to the effect that the plaintiff is owner and in possession of 10/158 share of land comprised in Khewat no. 1596, Khatoni no. 2440, Rect. No. 75 Killa no.1/1(0-10), 2/1min(0-1), 10(7-7) Kittas 3 area measuring 7 Kanals 18 marlas situated within the revenue estate of Village Dabwali, Tehsil Dabwali, District Sirsa, vide fard Jamabandi for the year 2012-13 read with sale deed bearing no. 3159 dated 24-02-1981 on the basis of which mutation bearing no. 5891 dated 23-2-1984 was entered and sanctioned and the defendants no. 1 And 2 have wrongly shown to be owner and in possession including their predecessor-in-interest, on the strength of sale deed bearing no. 1707 dated 24-08-1981 which is wrong, against law and facts, null and void, void abinitio, without authority, without competency as the defendant no. 3 was not competent to alienate the same and the mutation no. 18824 of the inheritance of deceased Ram Kishan, and the release deed bearing no. 2232 dated 8-7-2015 executed by the defendant no. 4 in favour of defendant no. 1 And 2 and its mutation no. 18830 are wrong, against law and facts, null and void, void abinitio, without authority, without competency, just paper transaction, ineffective and inoperative upon the rights of the plaintiff and the same are liable to be set-aside And with a consequential relief of permanent injunction restraining the defendants from alienating the suit land by way of sale deed, gift deed or creating any type of charge over the suit land and also restraining the defendants from interfering into the possession of the plaintiff over the suit land and also

restraining the defendants from changing the nature of the suit land by raising construction thereon, forcibly or illegally or in any manner on the basis of evidence oral as well as documentary of all kinds.
