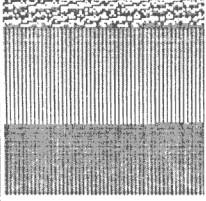

Parkash PCS Assistant Collector IInd Grade Sirsa in case titled as Babu Singh versus Bachan Singh vide which the predecessor-in-interest of the plaintiffs and performa defendants were held occupancy tenants of the suit land as they were in cultivating possession of the suit land without payment of any rent to anybody and considering themselves to be owners of the suit land as such the plaintiffs and performa defendants have a legal right to get themselves recorded into the revenue record as owners in possession of the suit land and further grant of a decree for declaration to the effect that the release deed bearing No. 1709 dated 25-6-2014 and its resultant mutation bearing No. 5577 sale deed bearing No. 234 dated 21-4-2014 and its resultant mutation bearing No. 5550 sale deed bearing No. 233 dated 21-4-2014 and its resultant mutation bearing No. 5551 sale deed bearing no. 235 dated 21-4-2014 and its resultant mutation bearing No. 5552 sale deed bearing No. 933 dated 26-5-2015 and its mutation bearing No. 5709 sale deed bearing no. 6660 dated 11-3-2016 and its resultant mutation bearing No. 5846 release deed bearing no. 2903 dated 12-8-2015 and its resultant mutation bearing No. 5758 and release deed bearing no. 2905 dated 12-8-2015 and its resultant mutation bearing No. 5921 and further the judgment and decree dated 6-10-2015 passed by the court of Shri Parvesh Singla the then learned Additional Civil Judge (Sr. Division) Dabwali in civil suit bearing no. 543 and its resultant mutation bearing No. 5932 and release deed no. 3976 dated 14-2-2017 and its resultant mutation no. 6033 are wrong against law and facts null and void void abinitio non est in the eyes of law does not effect the rights of the plaintiffs and performa defendants in the suit land without authority and without competence nothing but paper transactions and hence the same are liable to be set-aside and the subsequent revenue record showing the defendants or their predecessor-in-interest to be the owners and in possession of their respective shares are also wrong against law and facts null and void void abinitio hence the same is liable to be corrected in favour of the plaintiffs and performa defendants as the defendants have nothing to do with the suit land AND with a consequential relief of permanent injunction restraining defendants from alienating the suit land in any manner and also from causing any type of interference into the peaceful and lawful possession of the plaintiffs and performa defendants over the suit land in any manner on the basis of evidence oral as well as documentary of all kinds.
