

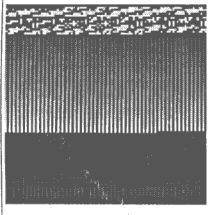

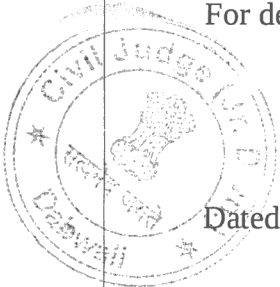

Suit for declaration to the effect that the plaintiffs are owners and in possession, in equal shares, of land measuring 5 marlas being 5/1256 share of land comprised in Khewat no. 1733, Khata no. 3250 to 3295, Kittas 54 area measuring 62 Kanals 16 marlas, as per fard Jamabandi for the year 2012-13 read with mutation no. 35482 as the defendant no. 1 has no concern with same and also the plaintiffs are owner and in possession, in equal shares, of land measuring 3(1/2) marlas being 7/2512 share of land comprised in Khewat no. 3250 to 3295, Kittas 54 area measuring 62 Kanals 16 marlas, as per fard Jamabandi for the year 2012-13 read with mutation no. 34194 as the defendant no. 2 has no concern with the same situated within the revenue estate of Nai Dabwali, Tehsil Dabwali, District Sirsa on the basis of mutation bearing no. 7352 dated 30-5-1982 and the defendants have no concern whatsoever with the same and their revenue record of said land is showing the defendants no. 1 And 2 to be owners in possession which is wrong, illegal, null and void, void abinitio and so the same is liable to corrected in favour of the plaintiffs AND further, the said sale deed bearing no. 1892 dated 24-6-2013 executed by defendant no. 3 in favour of the defendant no. 2 and the said sale deed bearing no. 1895 dated 24-6-2013 executed by the defendant no. 3 in favour of the defendant no. 2 is wrong, against law and facts, null and void, void abinitio, without consideration, without delivery of possession, without tauthority, without competence, nonest in the eyes of law, ineffective and in operative upon the rights of the plaintiffs qua the said land and the

same is liable to be set-aside as the defendant no. 3 was not having any title of said land and so no title of said land has passed in favour of the defendant no. 1 And 2 AND further with a consequential relief of permanent injunction restraining the defendants from further alienating or transferring the said land or any part there of to anyone forcibly, illegally or in any manner and also from creating any charge, bar or lien in any manner over the said land and the defendants may be restrained from raising any type of construction over the said land and further restraining the defendants from causing any type of interference into the possession of the plaintiffs over the said land forcibly, illegally or in any manner on the basis of evidence oral as well as documentary of all kinds.
