The plaintiff submits as under:-

- 1. That previously father of the plaintiff was owner in possession of the suit property mentioned in head note "A" of the plaint and the same is called as suit property. The father of the plaintiff Hari Chand s/o Faquir Chand purchased the suit property from Sewa Singh defendant no.1 vide registered sale deed no.1092, dated 16.07.1968, registered on 24.07.1968.
- 2. That all the defendants are pleaded as party as all are shown as co-owners in Jamabandi in property shown in head note "C" of the plaint. Primarily the prays for correction of Jamabandi of land shown in head note "B" from which father of the plaintiff purchased property mentioned in head note "A", but if Hon'ble Court come to the conclusion that total Khewat in which the defendant no.1 was owner that correction may kindly be made in Jamabandi regarding property shown in head note "C" i.e. total Khewat of the defendant no.1.
- 3. That at the time of sale suit property mentioned in head note "A", was part of property mentioned in head note "B" of the plaint, but defendant no.1 sold the property mentioned in head note "A" to the father of the plaintiff from property mentioned in head note "B" of

the plaint. But at that time total area of the Khewat in which property mentioned in head note "B" was mentioned, is shown in head note "C" of the plaint. Defendants no.1 to 28 are shown as joint owner in property shown in head note "B" of the plaint and all the defendants are shown as joint owners in property shown in head note "C" of the plaint.

- 4. That father of the plaintiff had died on leaving behind the plaintiffs and defendant no.143, but father of the plaintiff no.1 executed and registered his legal and valid will with his free mind in favour of the plaintiff no.1 on 13.06.03 registered on 23.06.03 as the plaintiff served his father Hari Chand during his life time. Mother of the plaintiffs died prior to the death of Hari Chand.
- 5. That the plaintiff is owner in possession of suit property mentioned in head note "A" of the plaint, property shown in head note "A" is residential house constructed by Hari Chand father of the plaintiff after purchased from the same in the year 1968 and house is there since than. Electric connection bearing no.K51KA320388F is installed in the house in question in the name of Hari Chand.
- 6. That the father of the plaintiffs purchased the plot from the property mentioned in head note "B" at that time, vendee defendant no.1 was owner of total land mentioned in head note "C" of the plaint and father of the plaintiff constructed his house in the property shown in head note "A" of the plaint.
- 7. That after purchase the father of the plaintiffs gave copy of the sale deed to the Patwari of Sirhind for the sanction of Mutation, hence presumed that Muation is sanctioned in the name of Hari Chand.
- 8. That after the death of Hari Chand the plaintiff no.1 went to the Patwari on 24.04.2015 for sanction of Mutation on the basis of registered will dated 13.06.03 executed by Hari Chand, but after visit Patwari, on 24.04.2015, the plaintiff no.1 comes to know that there is no Mutation in the name of Hari Chand, after that the plaintiff no.1 visited the revenue authorities for the purpose of Mutation on the basis of registered sale deed, but the revenue authorities frankly refused to sanction the mutation and said that there is no land remaining in the name of defendant no.1 Sewa Singh.

- 9. That the Hari Chand purchased five Marlas plot from defendant no.1 from proper mentioned in head note "B" and house of the plaintiff mentioned in head note "A" is also constructed in the property mentioned in head note "A" of the plaint
- 10. That at the time of registration of sale deed, PARCHA YAADASHT was also sent to the revenue authorities for the sanction of mutation, but the revenue authorities did not acted upon on those documents and by taking benefit of wrong record the defendant no.1 sold the land more than his share after the sale of the suit property mentioned in head note "A" of the plaint, hence sale deeds executed after the sale of the suit property to the plaintiff are liable to be ignored for the purpose of correction of the Jamabandis.
- 11. That the entry of the record of rights of the father of plaintiff Hari Chand is to be incorporated in Jamabandi for the year 1971-72 and all the subsequent Jamabandis, i.e. Jamabandi for the year 1976-77, 1981-82, 1986-87, 1991-92, 1996-97, 2001-02, 2006-07, 2011-12.
- 12. That the plaintiff or his father never checked the revenue record and were unable to calculate their share from the revenue record hence the mistakes in the Jamabandis were never noticed by the plaintiff or his father during his life time as the revenue record was not required for any purpose, the mistake first time comes to the knowledge of the plaintiff on 24.04.15, when the plaintiff visited Patwari regarding the mutation in his favour from the name of his father and after that the plaintiff approached the revenue authorities for the correction of the revenue record, after refusal from the revenue authorities the plaintiff collected revenue record after that and consulted their counsel for the suit.
- 13. That cause of action arose to the plaintiff to file the present suit on 24.04.15, when the plaintiff visited Patwari regarding the mutation in his favour from the name of his father and after that the plaintiff approached the revenue authorities for the correction of the revenue record, after refusal from the revenue authorities the plaintiff collected revenue record after that and consulted their counsel for the suit hence the suit is filed without any delay within limitation.

14. That the value of the suit for the purpose of court fee and jurisdiction for declaration is Rs.500 and for the purpose of permanent injunction is Rs. 500 hence proper court fee has

15. That the suit property is situated at Hamayunpur Sirhind, Tehsil & District Fatehgarh Sahib hence the hon'ble court has jurisdiction to try the present suit.

16. That no other suit is pending or decided by any court of law between the parties regarding the subject matter of the suit property and regarding the suit property.

It is therefore prayed that suit of the plaintiff under section 34 Specific Relief Act read with section 45 of Punjab Land Revenue Act for correction of Jamabandi from the years of 1971-72 to 2011-12 (Prevailing now), regarding suit property mentioned in head note "A" of the plaint as per registered sale deed no.1092, dated 16.07.1968, registered on 24.07.1968 may kindly be decreed with costs in the interest of justice.
