DETAILS OF LAND

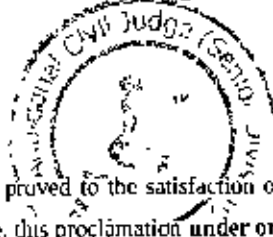
