A. Suit for declaration to the effect that the plaintiff is the co sharer in joint possession of the land measuring 20 kanals 3 marlas khewat no. 825.835,826 khatauni no. 1456,1422,14212 khasra no. 930,926,922/1 Situated in village daulatpur Tehsil and District pathakot and as entered in the jamabandi for the year 2011-12 (for the limited purpose of description of the land) and defendants no. 1 and 6 having purchased the land measuring 4 kanals 8 marlas, taraf lehnda ourt of khasra no. 930,926,922/1 from defendant no. 11 and 12 vide the registered sale deed dated 05/05/2006 document no. 644 cannot claim beyond any sahre and boundary of the land except as mentioned in the said sale deed and the sale deeds executed by defendant no. 1 in favour of defendant no. 2 to 4 vide the sale dated 18/6/2014, 3/10/2008 and 13/11/2007 cannot bestow on them the rights beyond the sale deed dated 05/05/2006 supra. And as a consequential relief suit for permanent injunction restraining the defendants from encroaching upon dispossessing and preventing the plaintiff from the exercise of tehirs rights as co sharer in the said land.

B. Suit for declaration to the effect that the mutation no. 13776/1 on the basis of the ikrarnama dated 18/7/2015 and on its basis securing the partiiton of the land by defendants no. 1 to 10 is illegal null and void and is liable to be set aside and the said defendants cannot claim any specific rights with respect to the said land and further from alienating, creating charge and raising construction over the land except after gettin gthe land partitioned be metes and bounds by due process of law.

C. Suit for permanent injunction restraining defendant no. 10 from encroaching upon from the nalla and the land of the plaintiff acroass the said nalla over the suit land and



thrus making the opening in the 20 feet wide passage made by the plaintiff for their self use and occupation.
