herewith marked by letters ABCD in red colour total land of the plaintiff i.e 17.67 marlas and after removing the malba from the portion FEDA i.e measuring 2 marlas out of the total land measuring 17.67 marlas which is under the illegal possession of defendant no. 4 sawinder singh @ robin singh as shown in red and blue colour in the annexed site plan as detailed in the above heading of the plaint with details of khasra number dimensions mere boundaries and measurements as mentioned above.

C. suit for permanent injunction restraining the defendant no. 3 and 4 from alienating mortgaging creating charge and from changing the nature of the property detailed in the heading(A) above.
