Documents to be produced:-

Candidates must bring following documents in original, along with one set of attested copies of documents mentioned at Sr. no. 1 to 6.

1. Proof of Graduation (Degree) & Detailed Marks Sheets (DMC). If the degree has not been conferred, provisional degree be produced.
2. Degree/Diploma in Computer Application-Minimum 6 months diploma from any Government recognized institution or any reputed institution which is ISO 9001 certified or possesses a Computer Information Technology Course or Equivalent to 'O' Level Certificate of DOEACC of Govt. of India.

3. Proof of Date of Birth (Matriculation Certificate showing Date of Birth/ D.O.B Certificate issued by Registrar of Birth and Death).
4. In Case of Employees of HLSA/DLSA/SDLSC/ PLA (PUS) will be required to submit a certificate regarding his/her service tenure in HLSA/DLSA/SDLSC/ PLA (PUS) issued by his/her employer.
5. Woman deserted by husband for more than two years will be required to submit an affidavit counter signed by two responsible persons such as members of the legislature, local bodies including Panchayats and the Bar Association.
6. Original Photo identity Proof.
7. Two passport size photographs one duly attested by the gazetted officer and other one unattested which was uploaded at the time of online submission of application.
