- 3. This online objection module shall remain active till 4.00 PM on 15.01.2015 and thereafter all the contents/webpage will be removed.
- 4. On the visiting the aforementioned webpage, candidate will have to fill his/her information regarding registration ID, roll number, name and date of birth. In case any of the information is found incorrect, no access to the online objection module will be available.
- 5. On successful login with aforesaid particulars, online objection module will open. Candidate have to mandatorily file his/her question booklet code, objected question numbers, proposed answer option and objector's answer option.

- 6. The 'Objection with Reason' is to be typed only in the given space briefly as far as possible.
- 7. Candidate can file objections to more than one question/proposed answer key. However, on one webpage, objection for only one question/proposed Answer Key will be entertained. For the next objection on other question/proposed Answer Key, at the end of typing area an option is available.
- 8. The candidate will have to select the 'Yes' or 'No' from the given option for next objection. In case of 'Yes', press button "Press for submission of Current Objection and for next page for New Objection". By pressing this button, typed objection will be saved and a fresh webpage will be available for submission/typing of next objection. The aforesaid procedure is to be followed for submission/saving and moving to next objection.
- On submission of objection(s), typed contents will be automatically saved in default download folder on the system of the candidate.
- On conclusion of process, the gist of the objected questions / answers will be uploaded and further cross objections will be invited only on those questions, in due course, if required.
- 11. On submission of objection, name, roll number etc. of the candidate will appear by default on his/her typed objection webpage.

- 12. The objections are being entertained in the interest of transparency, fairness and objectivity. Therefore, any attempt to play prank will be viewed seriously.
- 13. If candidate wants to support his objection by way of reference to any judgment or book, the complete citation of the judgment; title of the book, name of the Author, year or edition of publication, name of publisher and relevant page number must be mentioned in the 'Objection with Reason'. Further such judgment / relevant book page must be uploaded by way of attachment (the option given at the end of typing area) in PDF format only.
- 14. The High Court and Service Provider are not responsible for any loss of contents, data etc. due to defect / fault on the part of candidate or any third party.
- 15. For subsequent downloading/viewing (so long module is active) of his/her objections, the candidate have to login again on filing registration ID, name, date of birth and roll number and click download menu for saving and downloading of previously submitted objections.
