

## SPEECH

Their timely and healthy co-operation always helps in delivery of speedy justice. My tenure as Sessions Judge at **Rewari** as well as at **Panipat** has also been very satisfying. On the Administrative side also, I was fortunate to get best co-operation and affections from the Bar. The Bench and the Bar are two strong pillars on which stands the independent judicial system in our country. I would like to express sincere gratitude towards your part in my professional journey.

My elevation to this great **High Court** enhanced my knowledge, experience and ability. I am extremely thankful to all the esteemed Senior Judges with whom I shared the Bench and to also all brother and sister judges in whose company I enjoyed the happy moments. I deeply value the time spent with them. I thank them for creating such sweet memories in my mind and heart.

My special thanks to **Hon'ble The Chief Justice Mr. Justice S.J. Vazifdar**, who is always very pleasant and cheerful. The fragrance of his goodness can be felt every time you meet him.
