- Hon'ble Judges sitting in Hon'ble Division Benches after exhausting their lists may sit singly for taking up Single Bench cases.
- Special Benches will take up the cases on all Fridays.
- Mentioning of all the categories of cases will be made before Hon'ble the First Puisne Judge except the cases which are listed in urgent/motion/regular hearing before any Hon'ble Bench, the request for the same would be made before the said Hon'ble Bench.
- Cases upto the year 1990, cases relating to Senior Citizens, Crime against Women, differently abled persons, Juveniles, Marginalized Sections of society, Prevention of Corruption Act, cases in which proceedings before lower Courts have been stayed and remand cases from Hon'ble the Supreme Court will be taken up on priority basis.
- Ordinarily filed RSAs up to the year 2015 wherein notice is yet to be issued will be shown in urgent list.
