

**ARRANGEMENT IN CURRENT ROSTER W.E.F. 29.05.2023**

Vide separate Notifications No. K-13030/01/2023-US.II and K-13020/02/2023-US.I dated 26.05.2023 of Government of India, Ministry of Law and Justice, Department of Justice, the President of India has been pleased to appoint Hon'ble Mr. Justice Augustine George Masih to be the Chief Justice of Rajasthan High Court and Hon'ble Mr. Justice M.S. Ramachandra Rao to be the Chief Justice of Himachal Pradesh High Court.

In view of the above, Hon'ble the Chief Justice has been pleased to make the following arrangement in the current roster till further orders:
