

Hon'ble the Chief Justice has been pleased to order that during ensuing Baisakhi Vacation from 10.04.2021 to 16.04.2021, Anticipatory Bail Applications, cases relating to Life and Liberty (Protection matters of Runaway couples) and any other urgent matters, as may be permitted by the Hon'ble Judge nominated for mentioning during Baisakhi Vacations; will be entertained on 12.04.2021, 15.04.2021 & 16.04.2021.

Habeas Corpus Petitions will be entertained from 10.04.2021 to 16.04.2021.

Anticipatory Bail Applications and Protection matters of Runaway couples filed on 08.04.2021 (upto 12.00 Noon) wherein request for listing the same on 12.04.2021 is made on urgent form will be listed on 12.04.2021.

Anticipatory Bail Applications and Protection matters of Runaway couples filed on 08.04.2021 (after 12.00 Noon) and on 09.04.2021 (before 12.00 Noon) wherein request for listing the same during Baisakhi Vacations is made, will be listed during Baisakhi Vacations on 15.04.2021.

2. Request for listing the case for same day or next Court working day in case of Anticipatory Bail Applications and Protection matters of Runaway couples as well as taking of any other urgent matters including DB matters, if any, will be made through the 'Mentioning Portal' available on


the website of the Hon'ble High Court only, by specifically specifying the ground of urgency for hearing of the matter during the Baisakhi Vacations.

3. No filing except Anticipatory Bail Applications/Habeas Corpus/ Protection matters of Runaway couples and any other urgent matter as may be permitted by the Hon'ble Judge nominated for mentioning will be entertained during Baisakhi Vacations from 10.04.2021 to 16.04.2021.
