Hon'ble the Chief Justice has been pleased to order that during ensuing Winter Break 2022 w.e.f. 24.12.2022 to 03.01.2023, First Anticipatory Bail Application, Cases relating to Life and Liberty (Protection matter of Runway couples) and 'any other Urgent Matter' as may be permitted by Hon'ble the Senior most Vacation Judge through Registry; will be entertained on 26.12.2022 to 28.12.2022, 30.12.2022 and 02.01.2023 and 03.01.2023.

Habeas Corpus Petitions will also be entertained from 24.12.2022 to 03.01.2023.
