TERMS AND CONDITIONS

1. The Sealed Quotations, addressed to 'THE REGISTRAR GENERAL, PUNJAB AND HARYANA HIGH COURT, CAPITAL COMPLEX, SECTOR 1, CHANDIGARH' should reach in this office latest by 09.01.2017 till 4:00 P.M. Any offer received thereafter will not be entertained. The word "**QUOTATION FOR SURFACE LAPTOPS**" should be clearly inscribed on the top of the sealed envelope containing the quotation.
2. The price should be F.O.R High Court premises and inclusive of excise duty, freight, transit insurance, Sales Tax/VAT etc. The successful vendor is required to submit a certificate/undertaking to the effect that the rates are the lowest throughout India and it has not supplied such Laptops with same specifications and warranty to any other firm at the price lower than price charged from this High Court and if this High Court came to know at any stage that the firm has supplied such Laptops with the same specifications and warranty at the price lower than what is charged from this High Court, the Company undertakes to charge the same rates and refund the excess amount, if any.
3. The product should carry comprehensive onsite warranty for **THREE YEARS**, for the Laptops. The firm should have arrangements for providing of immediate after-sale services.
4. The vendor will be responsible for the comprehensive maintenance of all supplied equipments and related accessories free of charges during the warranty period.
5. The overall responsibility of installation and configuration would rest with the firm for proper & smooth integration of services and future support.
6. Payment will be made only after receipt of complete supply to the satisfaction of this High Court and no advance payment will be made in any case.
