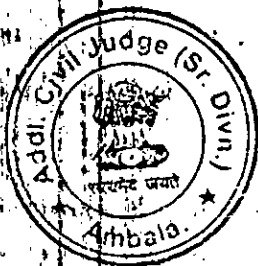
Whereas the petitioner **MADAN LAL** has filed the above petition before this Court for the grant of Succession Certificate regarding the assets left by the deceased, who died on .
