Suit for a Decree for Declaration to the effect that the alleged sale deed dated 13.08.2084 along with its mutation no. 728 pertaining to the land bearing khewat/ Khatauni no. 569/916 comprised in Khasra No. 351 (0-5) I.e Gair Mumkin Bara as shown in colour red in the annexed site plan situated in village Ballana Tehsil & Distt Ambala allegedly shown to be executed by the plaintiff and defendant no. 5 to 7 in the favour of the defendant no. 1 is wrong, illegal, null void, ineffective inoperative qua the rights of the plaintiff and result of misrepresentation and fraud on the part of defendants in manipulating the state of affairs and execution of alleged sale deed 26.09.1991 shown to be executed by defendant No. 1 in favour of defendant no. 2, and alleged sale deed dated 26.09.1991 bearing document no. 8130/1 shown to be executed by defendant no. 1 in favour of defendant no. 3 alongwith alleged sale deed dated 21.11.2003 bearing document no. 4998 shown to be executed by L.r's of defendant no. 3 in favour of defendant no. 4 are also illegal, null and void and not binding on the legal rights of the plaintiff with the consequential relief of possession of the aforesaid land and for permanent Injunction restraining the defendant no. 1 to 3 from further alienating, mortgaging and creating any charge over the property in question through themselves or through agents in any manner whatsoever as per Jamabandi for the year 2013-14 under order 07 rule 1 of C.P.C.
