Suit for declaration to the effect that the plaintiff is owner in possession of Gair-Mumkin land measuring 0 Kanal-4 Marla being 1/4th share of Gair-Mumkin plot bearing Khasra No. 981(0-16) situated in the revenue estate of Basti Bhiwan, Tehsil and Distt. Fatehabad on the basis of civil court decree dated 23.01.1992 passed by the Honble Court of Sh. B. Diwakar the then Sub Judge First Class Fatehabad in civil suit no. 26 dated 09.01.1992 titled as Ram Sarup versus Smt. Chanda Devi and therefore the plaintiff is entitled to get his name incorporated in the revenue record as owner in possession of above mentioned Gair-Mumkin land and rejection of mutation no.10373, 10374, 10375, 10376 after review and sanction of mutations no. 14297, 15401, 15497, 24158 after review in respect of above mentioned land and mutation no. 8011 dated 22.03.1996 are illegal, null and void and alleged sale deed no. 2847 dated 07.03.1991 allegedly executed and got registered by Hans Raj s/o. Dhannu Ram s/o. Ganga Ram predecessor-in-interest of defendants no. 6 to 11 in favour of defendant no.1 in respect of Gair-Mumkin land measuring 0 Kanal-4 Marla being 1/4th share of aforesaid land bearing khasra no.981(0-16) and subsequent mutation no.14297 dated 14.06.2005 of inheritance of said Hans Raj s/o. Dhannu Ram in favour of defendants no. 6 to 11 and subsequent mutation no. 15401 dated 18.11.2005 in respect of suit land in favour of defendants no. 4 and 5 and subsequent sale deed no.4302 dated 09.11.2005 allegedly executed by defendants no. 4 and 5 in favour of defendant no.2 and subsequent sale deed no. 5957 dated 20.11.2012 allegedly executed by defendant no. 2 in favour of defendant no.3 are without title, without authority and thus the aforesaid sale deed no. 2847 dated 07.03.1991 and its resultant

mutation no. 8011 dated 22.03.1996 and mutation no. 14297 dated 14.06.2005 and mutation no. 15401 dated 18.11.2005 and sale deed no. 4302 dated 09.11.2005 and its resultant mutation no.15497 sanctioned on 17.12.2005 and sale deed no. 5957 dated 21.11.2012 and its resultant mutation no. 24158 dated 24.01.2013 and subsequent resultant entries in the revenue record in favour of the defendants are wrong, against law and facts, without title and authority and are illegal, null and void and are not binding on the rights of the plaintiff and are liable to be set aside and further suit for permanent injunction to the effect that the defendants no.1 and 3 be restrained from alienating and transferring suit land and creating any encumbrance over it.
