Suit for declaration to the effect that as the minor girm Pritika who was born on 20-11-20221 out of the wedlock of her natural parents namely Mhender Sigh son of Hari Singh i.e. the Def.No. 2 and Niru wife of Mahener Singh son of Hari Singh since deceased on 23-02-2022 at village Khanak Tehsil Tosham Distirct Bhiwani whose name i.e. minor Pritika was duly registered on 23-11-2021 in the birth and Death records in the office of the defendant No. 5 under the control of defendant No. 3 and 4 is the adopted daughter of the plaintiffs namely Dharamvir son of Rangi Ram and Sumitra wife of Dharambir son of Rangi Ram on the basis of oral adoption of minor Pritika took place immediately after her birth (20-11-2021) and subsequently followed by a Registered Adoption Deed bearing No. 18 dated 21-02-2022, duly executed and got registered inthe office of the Sub Registrar, Narnaund District Hisar by the defendant No. 1 Mahender Singh and his wife namely late Niru during her lifetime who has since died on 23-02-2022 i.e. the natural parents of minor Pritika, therefore, the plaintiffs namely Dharambir and Sumitra are legally entitled to get their names incorporated as adopted father and mother (i.e. Dharamvir son of Rangi Ram and Sumitra wife of Dharamvir son of Rangi Ram respectively in place of the defendant No. 2 Mahender Singh son of Hari Singh i.e. natural father and Niru (now deceased) wife of Mahender Siongh son of Hari Singh inthe records of defendant Nos. 3 to 5 i.e. Haryana State through Collector, Fatehabad, Civil Surgeon-cum-Registrar, Birth and Death, Civil Hospital, Fatehabad and Registrar (Birth and Death), Primary Health Centre, Nehla with a consequential relief of mandatory injunction directing the defendant Nos. 3 to 5 to record necessary entries to this effect in the relevant records in their office and also to issue the Birth Certificate of the minor Pritika afresh after incorporating necessary corrections therein qua her father name name as Dharambir and mother name as Sumitra to the plaintiffs forthwith, on the basis of oral and documentary evidence of all kinds.
