Suit for declaration to the effect that the plaintiffs are owner in possession of land measuring 59 Kanal 16 Marla detailed as plaintiff no. 1 is owner in possession of 40 Kanal 9 Marla and plaintiff no. 2 is owner in possession of 19 Kanal 7 Marla in land measuring 835 Kanal 11 Marla comprised in khewat no. 20 as per jamabandi for the year 1964-65, now bifurcated in three khewats khewats no. 3, 4, 5 as per jamabandi for the year 1974-75 to 2014-2015 situated in village Bhundra Tehsil and District Fatehabad, by way of reconsolidation of three khewats no. 3, 4 and 5 into single khewat as it was in jamabandi for the year 1964-65 by way of declaration that the sale deed no. 2787 dated 16.02.1968 in favour of defendants no. 48 to 50 (vendors of defendants no. 51 to 54) regarding land measuring 181 Kanal 0 Marla bearing khasra no. 25//16 min (1-12), 24 (8-0), 25(8-0), 26/7(9-9), 10(8-0), 11/1(3-4), 11/2(3-9), 12(8-0), 13 (8-0), 14 min (3-18), 18(8-0), 19(8-0), 20(8-0), 21(8-0), 22(8-0), 23(8-0), 36//1(8-0), 2(8-0), 3(8-0), 8(8-0), 9(8-0), 10(8-0), 12/1(7-7), 37//4(8-0), 5(8-0) in favour of Sewa Singh, Pal Singh sons of Malkiyat Singh son of Massa Singh, Balbir Singh son of Kartar Singh son of Kehar Singh resident of Digoh all in equal share, is wrong and illegal to the extent of 89 Kanal 16 Marla excess sold by Bhagat Singh predecessor of the defendants no. 4 to 10 and the sale deed no. 1361 dated 10.12.2002 regarding land measuring 69 Kanal 9 Marla which is 1/3 share of land measuring 208 Kanal 7 Marla khat 37 comprised in khewat no. 3 khatoni no. 4 in favour of the defendant no. 9 Amrik Singh and the defendant no. 10 Nachhatar Singh. Further suit for permanent injunction to the effect that the defendants No. 4 to 10 and defendants no. 51 to 54 be restrained from further alienating the suit land on the basis of wrong entries in the revenue record and the defendants no. 57, 58 be restrained from dispossessing the plaintiffs from the suit land till decision of title of suit land between parties. On the basis of oral and documentary evidence of every description.
