Suit for declaration to the effect that the plaintiff have acquired occupancy/ownership rights in respect of land measuring 24 Kanals 0 Marla comprising khewat no. 2944//2788 khatauni no. 3312 Khasra no. 34//13 (8-0), 18(8-0), 23(8-0) situated at Hisar tehsil and distt hisar as per fard jamabandi for the year 2018-19 under the provisions of section 5(1)(a) read with section 5(2) and sections 8-9 of the punjab tenancy act 1887 (as amended upto date) and have become owners of it under the provision of section 3 of the punjab occupancy tenants (Vesting of Proprietary Rights) Act, 1952 and as such are entitled to be recorded as owners in possession of the above suit land in the revenue records and the the alleged entry of batai tihai coming in the revenue records is quite wrong, illegal against law and liable to be set aside accordingly as the plaintiffs are coming as gair maurusi tenants on nominal rent and as a consequential relief of injunction restraining the defendants and other persons from interfering or dispossessing the plaintiffs from their peaceful continuous ownership possession over any part of the suit property which is in continuous possession of the plaintiffs for the last about 50 year since the time of their predecessor-in-interest Sh.Prithvi Raj and also restraining the defendants from alienating/transferring or encumbering the suit property in favour of any person by way of sale, gift, mortgage or decree etc. in any manner on the basis of evidence of every description oral as well as documentary.
