Suit for declaration to the effect that Asha Rani daughter of Om Parkash Bhutani and earlier wife of Ved Parkash, resident of H.No.57/20C, Partap Nagar, Jahajpul, Hisar Tehsil and Distt.Hisar, who is mother of the plaintiffs has not been seen and heard since 07.01.2008 i.e. for more than seven years by the persons who would have naturally heard of her if she had been alive and an such Asha Rani, above named, be deemed to have died a Civil Death in view of the provision contained under section 108 of the Indian Evidence Act, 1872 and that the plaintiffs, being sons, are her legal heirs and are entitled for getting the ownership and possession in equal share in their favour with regard to the 1/2 share of Asha Rani in House built plot measuring 22X48 comprised in Khasra No.1579/26 min situated in Municipal Record/other Government official Record etc. and similarly the plaintiffs are entitled for inheritance of other properties in equal share belonging to Asha Rani, if any and the defendants have no right, title, interest or claim in the aforesaid house/property under the provisions of the Specific Relief Act, on the basis of evidence of every kind.
