Suit for Permanent Injunction (Prohibitory and Mandatory) to the effect that the plaintiff is co-sharer (owner) of khewat no. 235//213, Khatauni No. 336, Khasra No. 71//8(8-7), 9/1(5-0), 9/3(0-19) kitta 3 measuring 14 Kanal 6 Marla situated at village Mirpur Tehsil and District Hisar and the defendants have purchased 13/214 share to the extent of 0-17.37 Marla i.e 525, sq. yards in joint account vide sale deed no. 2952 dated 15.06.2021 from co-sharers Maohar Lal And Jagdish Kumar, but at the spot both the defendants are now constructing the shops in front portion of the land on Bhuna Road without get any partition and partition petition is pending in the court of Ld. Tehsildar, Hisar and the same is fixed for 16.06.2023 and similarly and defendant No. 2 also purchased in the above said Killa Numbers measuring OK-3M from the same co-shares vide sale deed No. 9621 dated 07.01.2020 and now forcibly without getting any partition defendant No. 2 also constructing the shops and house in front of the land i.e Bhuna Road which they have no legal rights of any type, because a Civil Decree in case of Chander Bhan Versus Jagdish and others which was instituted on 31.07.2019 decided on 03.04.2023 in which it has been specifically decreed that "It is ordered that the suit of the plaintiff succeeds and the same is hereby decreed with cost to the effect that parties to the present suit are hereby restrained from selling disposing off, mortgaging specific

Khasra/Killa number out of the joint holding comprised in Khewat No. holding comprised in Khewat No. 225//213, Khatoni No. 336 and Khewat no. 227/217. Khatoni No. 338 and 339 without getting the same partitioned. The parties shall, however be at liberty to alienate or transfer etc. their share in the joint holding." In these circumstances, defendants have no right to construct the shops and house in the joint suit property and legally they the defendants be restrained in view of the civil suit already decreed with a consequential relief of mandatory injunction against the defendants that they be restrained not to construct the shops and house in front portion on Bhuna Road on a specific front portion without getting partition of the suit land measuring 14 Kanal 6 Marla comprised in Khewat No. 235//213, Khatoni No. 336 in the revenue estate of village Mirpur, Tehsil and District Hisar on the basis of evidence of all kinds.


