Hanuman including but not limited to the and also to the following moveable and immovable properties to the extent of 1/6th share each in respect of plaintiffs no. 1, 2 to the extent of one sixth each in respect of proforma defendants no. 2, 3, 4 and to the extent of one sixth share in equal shares in respect of the proforma defendants no. 5 to 8 1. one fourth share of Hanuman left in the land measuring 58 Kanal 3 Marla bearing Khewat No. 55 52, Khatauni No. 68, situated at Village Mirzapur Tehsil and District Hisar, as per the Jamabandi for the year 2008-09, 2. one third share of Hanuman left in Gair Mumkin Plot measuring 0 Kanal 15 Marla bearing Khewat no. 70//59, Khatauni No. 83, situated at village Mirzapur, District Hisar as per the Jamabandi for the year 2013- 14 and similarly the plaintiff and proforma defendants are entitled for inheritance of other properties belonging to Shri Hanuman that may be found to be in his name, in future and the defendant has no right, title, interest or claim in the aforesaid properties under the provisions of the Specific Relief Act. on the Basis of Evidence of All Kinds Oral as Well as Documentary
