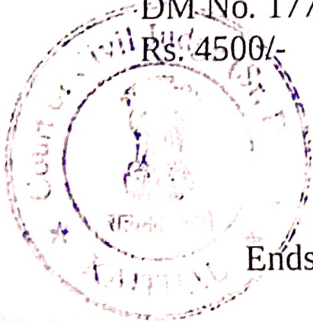
Suit for Declaration & Injunction
