Suit for partition

It is therefore, respectfully and most humbly prayed that a decree for partition of the suit property i.e. Land measuring 12 kanals 17 marlas comprised in khewat no. 1268//1224, khatoni no. 1345, Rect. No. 79, khasra no. 21 min (3-10 gair mumkin plot), Rect No. 80, khasra no. 25/2/1min(1-7 gair mumkin plot), khatoni no. 1346, Rect no. 79, khasra no. 21 min(3-10 gair mumkin plot), Rect no. 80, Khasra no 25/2/1min(4-10 gair mumkin plot) situated at village Jhambra Shahabad, Hadbast No. 253, Tehsil Shahabad, District Kurukshetra vide jamabandi for the year 2014-2015 read with mutation no. 20845 dated 30.11.2017, 20852 dated 30.11.2017, 22028 dated 20.03.2019, 20012 dated 20.01.2017, 21082 dated 16.01.2018, 20201 dated 24.03.2017, 20215 dated 19.04.2017 21548 dated 25.07.2018, 19689 dated 23.11.2016, 19835 dated 07.12.2016 may kindly be passed in favour of the plaintiff and against the defendants with costs, whereby the plaintiff may kindly be put in exclusive possession as exclusive owner of the portion of the suit property to her respective share as mentioned in the revenue record by making specific kurra (compact) of plaintiff and the plaintiff may kindly be put in exclusive possession as exclusive owner of the portion of same, at the spot with consequential relief of permanent injunction restraining the defendants from alienating, selling, transferring, leasing, mortgaging any part of the suit property in favour of any stranger (s) forcibly and illegally and from changing the nature of the suit property by raising further construction on any part of the suit property and further the defendants may kindly be restrained from damaging, dismantling, demolishing any part of the suit property in any manner or forcibly and illegally, may kindly be passed in favour of the plaintiff and against the defendants with costs in the interest of justice

Any other relief to which plaintiff are found entitled by this Hon'ble Court may kindly be granted to the plaintiff and further any other additional or alternative relief to which the plaintiff becomes entitled during the pendency of the present suit may kindly be granted to the plaintiff.
