Suit for declaration with permanent injunction under order 7, Rule 1 CPC Read with Section 34 to 39 of Specific Relief Act.

Prayed that a decree for declaration to the effect that the plaintiffs are joint owners in joint possession as co-sharers of the land measuring 14 Kanals 9 Marlas being 289/8677 share of total land measuring 433 Kanals 17 Marlas detailed as under:

Any other relief to which the plaintiffs are found entitled by this Hon'ble Court may kindly be granted to the plaintiffs and further any other additional or alternative relief to which the plaintiffs become entitled during the pendency of the present case may kindly be granted to the plaintiffs.
