a decree for declaration to the effect that the plaintiffs no.1 to 3 being legal heirs of late Parmanand are owner in possession in equal share of 2411 Sq. feet and plaintiffs no.4 and 5 being legal heirs of Desh Raj are owner in possession in equal share of the 2012 Sq feet out of suit property detailed in para no.1 of the plaint on the basis of registered sale deed no. 1397 dated 19.08.1977 executed by Tek Chand predecessor of present defendants no.1 to 3 and on the basis of civil court award passed in civil suit no.359 of 2010 decided on 15.01.2011 by the Court of Sh. Kuldeep Singh the then Civil Judge(Junior Division), Pehowa and a decree for mandatory injunction directing the defendant no.4 to enter and sanction the mutation of sale deed no. 1397 dated 19.08.1977 and Civil Court award passes in Civil Suit no.359 of 2010 as well as of inheritance of late Parmanand and Desh Raj in favour of the present plaintiffs may kindly be passed in favour of the plaintiffs and against the defendants and a decree permanent injunction restraining the defendants from alienating the suit land through any mode of transfer and from creating any charges thereon and from dispossessing the plaintiffs from the suit land and from their legal continuous, peaceful and long possession over the suit property, forcibly and illegally may kindly be passed in favour of the plaintiffs and against the defendants in the interest of justice.

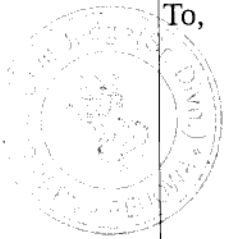
