Amar Singh Father of the Plaintiff in Favour of the defendant No. 1 in respect of the land measuring 46 K-10 M i.e. 1/2 share of land owned by Late Sh.Amar Singh S/o Bhagwan Singh father of the plaintiff as fully detailed in the head note of the plaint situated at pehowa tehsil pehowa district kurukshetra as per the mutation No. 1893 based on the decree dt. 22.11.1973 passed by the Learned Court of Sh.
