It is, therefore, prayed a decree for declaration to the effect that the plaintiff is owner in joint possession of the land as mentioned in para no. 3,4 and 5 of the plaint and the entries in the revenue record are against the facts and law and the plaintiff is not bound by the wrong revenue entries on the basis of mutation no. 609 and subsequently revenue entire i.e. Jamabandi for the year 20.11.2012 by passing a decree in favour of the plaintiff and against the defendants and further a decree for mandatory injunction directing the defendant no. 6 to enter and sanction the mutation in favour of the plaintiff on the basis of sale deed mentioned in para no. 3,4 and 5 of the plaint by passing a decree in favour of the plaintiff and against the defendants and a consequential relief of the permanent injunction, restraining the defendants from interfering in the ownership and joint possession of the plaintiff over the land in question as detailed in para no. 3,4 and 5 of the plaint by passing a decree in favour of the plaintiff and against the defendants with costs of the suit, in the interest of justice. Any other relief for which the plaintiff is found entitled in the circumstances of the case may please also be awarded to the plaintiff against the defendant by passing decree in favour of the plaintiff.
