Suit for declaration to the effect that the plaintiffs being class-I legal heirs of Sh. Ashok Pathak (now deceased) are owner in possession of area measuring 27-1/2 feet X 77 feet (5 Karam X 14 Karam), private plot no.58, situated in C-Block, Lord Shivpuri, Green Belt Village Sikendapur, bounded as on East Plot No.63 of Sh. Rameshwar Dass measuring 27-1/2 feet, West Rasta measuring 4 Karam, North Rasta measuring 2 Karam (77feet) and South Plot No.57 of Sh. Prem Kumar measuring 77 feet, on the basis of sale deed no.3145 dated 17.10.1984, registered in the office of Sub Registrar, Sirsa still showing defendant no.1 as owner is quite contrary to the sale deed, are wrong, incorrect, against law, against facts, and as such, the same are liable to be corrected as per aforesaid sale deed no.3145 dated 17.10.1984 and likewise all other subsequent revenue record entries prepared on the basis of same are also liable to be corrected accordingly, further defendants are restrained from doing any illegal, unlawful act for interfering into the lawful possessory rights of the plaintiffs by using coercive and forcible method on the basis of wrong and contrary entry in the revenue record, and as a consequential relief for mandatory injunction, directing the defendants for making necessary correction in the revenue record as per registered sale deed no. 3145 dated 17.10.1984, on the basis of evidence of every description, oral as well as documentary.
