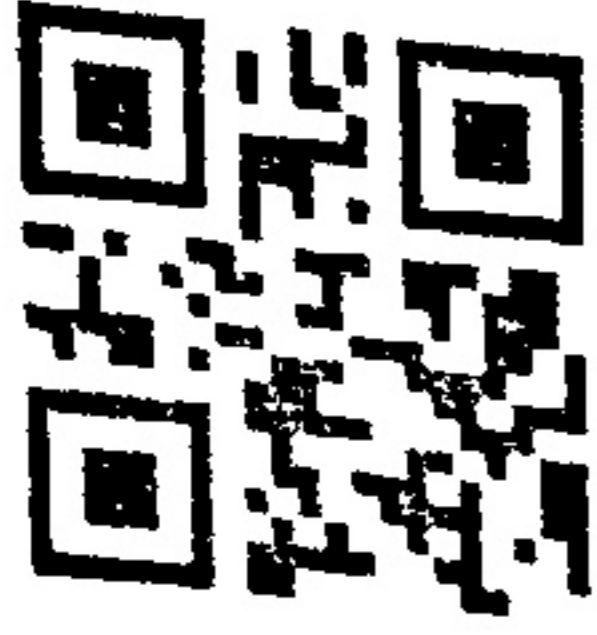

Suit for declaration to the effect that Ganpat Ram alias Ganpat son of Shri Nathu Ram son of Sh Moti resident of Village Madhosinghana, Tehsil and District Sirsa has been died being not heard or seen by the plaintiffs, their family members, relatives, villagers as well as the neighbours for the last more than 13.5 years (since 11.03.2011) and on the basis of Rapat Rojnamecha bearing DDE No.16 dated 29.03.2016 got registered in Police Post Mallekan, PS Sadar Sirsa, District Sirsa and further for declaration to the effect that the plaintiffs being sons and daughter and only legal heirs of Ganpat Ram alias Ganpat are legally entitled to be declared as entitled to take over all the rights whatsoever which were available to Ganpat Ram alias Ganpat as he was living on the earth and besides above as per law and the relevant provisions of Hindu Succession Act, the plaintiffs being the legal heirs of the said Ganpat Ram @ Ganpat are also entitled to be declared as lawful owners in possession of land measuring 46 Kanal 18 Marla 4 Sarsai detailed as- (1)-Land measuring 0 Kanal 12 Marla 4 Sarsai being 1/2 share out of land measuring 1 Kanal 5 Marla comprised in Khewat No.203 Kittas 2, (2)-4 Land measuring 45 Kanal 16 Marla comprised in Khewat No.205 Kittas 8 and (3) Land measuring 0 Kanal 10 Marla being 1/2 share out of land measuring 1 Kanal 0 Marla comprised in Khewat No 206 situated at Village Madho Singhana, Tehsil and District Sirsa as per Jamabandi for the year 2017-2018 AND other estates whatsoever, if any, existed and recorded in the name of dead person-Ganpat Ram alias Ganpat, on the basis of evidence of every description oral as well as documentary.

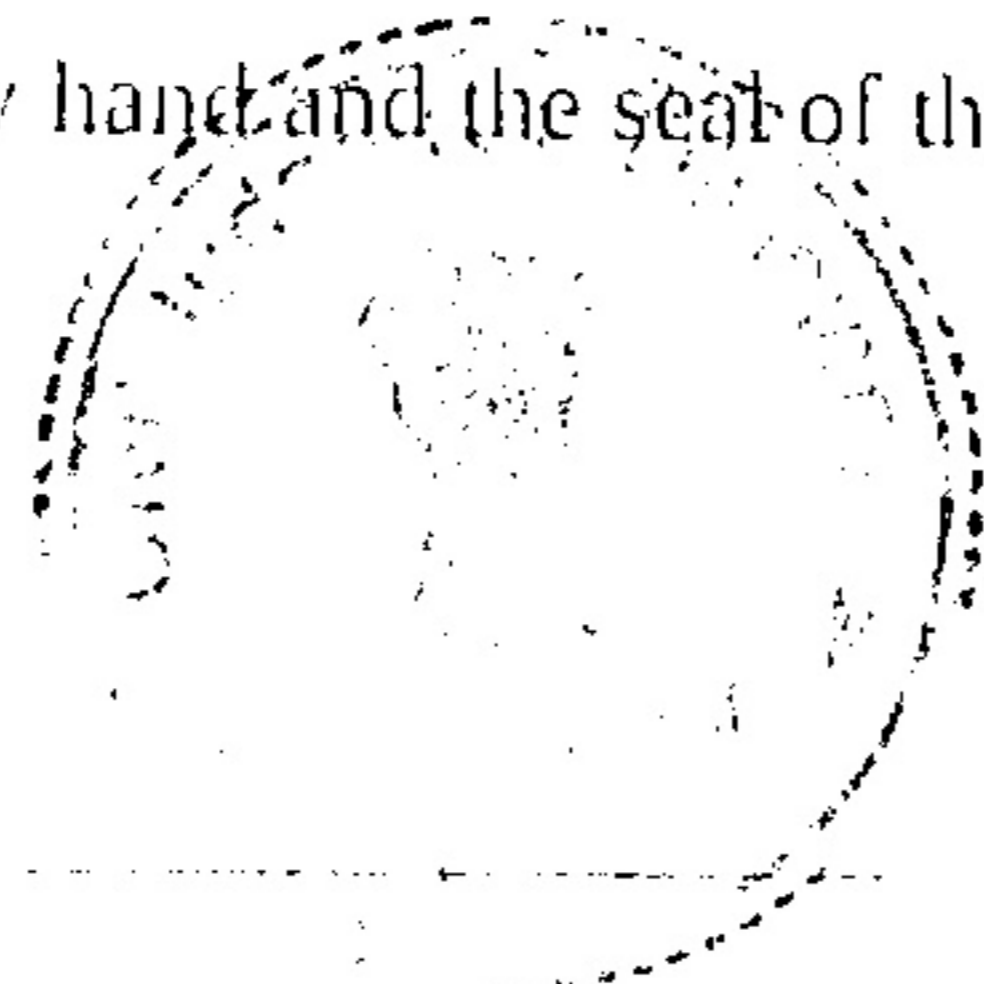
