The petitioner submitted as under: -

1. That the applicant is the mother and natural guardian of the minor Sukhleen Badwal who's date of birth is 22-11-2001. The minor child is residing in the custody of the applicant (mother). The father Ravinder Singh minor Sukhleen Kaur died on 26-10-2016. Photo copy of the death certificate is attached herewith.
2. That the father of the minor had purchased ~~of~~ land in VPO Bagpur P.S. Haryana Tehsil and District Hoshiarpur. The mutation of inheritance in respect of the share of deceased Ravinder Singh was sanctioned in the name of his wife and minor daughter.
3. That the share of minor in the property in dispute cannot be looked after in an effective way and thus has become nonprofit yielding share.
4. That to seek the welfare of the minor it is very much necessary that the share of the minor be put to sale and proceeds of the sale is deposited in sum nationalized bank. The applicant is maintaining and is imparting best education to the minor. The minor are studying in higher classes in the reputed schools.

5. That in the absence of actual father who has since died, the applicant is the legal guardian to be appointed of the person and property.
6. That the property in dispute is situated in the revenue estate of Village Bagpur Tehsil and District Hoshiarpur and the parties to the application are also ordinary residing within the jurisdiction of this Hon'ble court.
7. That the requisite court fee has been affixed on the application.
8. That no similar petition is pending or decided between the parties with regard to the subject matter.

It is, therefore, prayed that the application of the applicant be accepted and necessary order be passed in favour of applicant in the interests of justice.
