Suit for declaration to the effect that the plaintiffs are the owners in possession of the property/plot measuring 7 Marlas 16 Sq. Ft. i.e. 1920 Sq. Ft., comprised in Khasra No. 5//5(6-16), 17/2(0-10), 24(0-9), 25Min(4-0), 28(0-10), 29(2-11), 30(0-8), 38(1-1), 3//17/2(0-12), 18(0-7), 22/2(2-3), 23(7-16), 24/1(5-15), 25/2(2-15), 5//3(7-9), 4(8-0), 6(7-8), 7(8-0), 8(6-4), 13/3(2-4), 14/1(7-6), 5//15(6-3), 16(5-15), 17/1(2-17), 4//21(0-8), 5//25Min(3-12), 9//5(6-6), 6(8-0), 15/1(4-4), 10//1(1-18), 10(2-18), 11/1(1-18), 5//2/2(0-9), situated in the area of Village Chak Jinda, Hadbast No.159, Tehsil and District Jalandhar on the basis of registered sale deed no. 9095 dated 16.01.1992, executed by Gurcharan Singh son of Puran Singh, through his general attorneys and then special attorney Sh. Gurmeet Singh son of Sawarn Singh, alongwith all the rights appurtenant thereto.

Consequently for permanent injunction restraining the defendants or their agents, attorneys, nominees, employees, representatives in any capacity from interfering in peaceful possession of the plaintiffs and from alienating, mortgaging, exchanging, leasing, creating any charge over the suit property.

Sir,

It is submitted as under:-

- 1) That Sh. Gurcharan Singh son of Puran Singh son of Nidhan Singh was owner in possession of the land comprised in Khewat No.7, Khatoni No. 9, 10, 11, 12 as per jamabandi for the year 1986-87 and the khasra numbers mentioned in the headnote of the plaint. Said Sh. Gurcharan Singh himself and through his general and special attorneys, carved out a colony/plots and started selling the plots to the different persons. Similarly, Major Tejinder Singh Sekhon predecessor in interest of the plaintiffs, purchased a plot measuring 7 marlas 16 Sq. Ft.(1920 Sq. Ft.) vide registered sale deed no.9095 dated 16.01.1992 duly executed by Sh. Gurmeet Singh son of Sawarn Singh special attorney of Aseem Sagar and Gurjinder Singh who were general attorney of original owner Gurcharan Singh son of Puran Singh.
- 2) That S. Tejinder Singh Sekhon predecessor in interest of the plaintiffs while paying the entire sale consideration, got the sale deed executed and registered and got the possession of the plot in question and filled the foundations. Said Sh. Tejinder Singh Sekhon unfortunately expired on 14.02.2014 leaving behind the plaintiffs as his Class-I legal heirs according to Hindu Succession Act. Said S. Tejinder Singh Sekhon during his lifetime remained in possession of the property/plot in suit as owner. Since after his death, the plaintiffs are in possession of the property/plot in suit as owners. That dispute arose in May 2016, when unknown persons came to the spot and started threatening to get the possession of the property in suit. The plaintiffs being law abiding citizens put themselves in search of the revenue record and came to know in February 2017 that the mutation on the basis of registered sale deed dated 16.01.1992 is not sanctioned in the revenue records, which is a mistake on the part of the revenue officials. The law is well settled that it is duty of the revenue officials to keep the revenue record update. Due to aforesaid mistake, the complications/dispute arose up. That the plaintiffs being law abiding and peace loving citizens, approached the Patwari halqa with the request to enter and sanction the mutation on the basis of sale deed dated 16.01.1992, but he told that the original owner has sold much more area than due to him and due to the said mistake, the mutation on the basis of sale deed dated 16.01.1992 is not sanctioned/reflected in the jamabandi. Thus, the entries in the jamabandi are wrong, as the persons who purchased the property much after the date 16.01.1992, are recorded in the ownership column, which entries are inherently wrong and do not cast clouds over the rights of the plaintiffs. That some unknown persons alleging to be representatives of the defendants, are still threatening to get the possession of the suit property and to alienate the same, for which

they are not entitled. In case, they succeeded in doing so, the plaintiffs shall suffer irreparable loss and injury, which cannot be compensated in the terms of money. Therefore, the plaintiffs are entitled to declaration and injunction as prayed for.

- 6) That the plaintiffs being law abiding citizens often requested the defendants not to take law in their hands and not to disturb the possession of the plaintiffs over the suit property, but they have flatly refused to accede the request of the plaintiffs in last week. Therefore, there is no option for the plaintiffs, except to file the present suit.
- 7) That the cause of action has accrued to the plaintiffs in May 2016, February 2017, and in week, when the defendants started threatening and tried to get the possession of the suit property forcibly and cause of suit has accrued in last week, when the defendants have refused to accede the request of plaintiffs.
- 8) That no similar suit on the same cause of action is filed or pending between the parties w.r.t. the property in suit.
- 9) That the value of the suit for the purpose of court fee and jurisdiction is Rs. 195/- for the relief of declaration and Rs. 130/- for the relief of permanent injunction, on which a requisite court fee is affixed on the plaint as per Amended Court Fee Act.
- 10) That the property in suit is situated in Village Chak Jinda, Tehsil & District Jalandhar, which is within the jurisdiction of this Hon'ble Court, hence this Hon'ble Court has jurisdiction to entertain, try and decide the present suit.

It is, therefore, prayed that a decree for declaration to the effect that the plaintiffs are the owners in possession of the property/plot measuring 7 Marlas 16 Sq. Ft. i.e. 1920 Sq. Ft., comprised in Khasra No. 5//5(6-16), 17/2(0-10), 24(0-9), 25Min(4-0), 28(0-10), 29(2-11), 30(0-8), 38(1-1), 3//17/2(0-12), 18(0-7), 22/2(2-3), 23(7-16), 24/1(5-15), 25/2(2-15), 5//3(7-9), 4(8-0), 6(7-8), 7(8-0), 8(6-4), 13/3(2-4), 14/1(7-6), 5//15(6-3), 16(5-15), 17/1(2-17), 4//21(0-8), 5//25Min(3-12), 9//5(6-6), 6(8-0), 15/1(4-4), 10//1(1-18), 10(2-18), 11/1(1-18), 5//2/2(0-9), situated in the area of Village Chak Jinda, Hadbast No.159, Tehsil and District Jalandhar on the basis of registered sale deed no. 9095 dated 16.01.1992, executed by Gurcharan Singh son of Puran Singh, through his general attorneys and then special attorney Sh. Gurmeet Singh son of Sawarn Singh, alongwith all the rights appurtenant thereto.

AND

Consequently, a decree for permanent injunction restraining the defendants or their agents, attorneys, nominees, employees, representatives in any capacity from interfering in peaceful possession of the plaintiffs and from alienating, mortgaging, exchanging, leasing, creating any charge over the suit property, may kindly be passed in favour of the plaintiffs and against the defendants, with costs.
