Gurbakhsh Singh son of Sh. Ganda Singh son of Sh. Rattan Singh, resident of Village Sarhali, Tehsil Phillaur, District Jalandhar, in favour of plaintiff and his deceased brother namely Inderpreet Singh along with all other rights appurtenant thereto, after declaring that the alleged mutation no.6028 pertaining to the land situated in the revenue

area of Village Sarhali, Tehsil Phillaur, District Jalandhar, passed by the Honble Court of Mr. S. M. Sharma, PCS, the then A.C. 1st Grade, Tehsil Phillaur and alleged mutation no. 2477 pertaining to the land situated in the revenue area of Village Darvesh Pind, Tehsil Phagwara, District Kapurthalla, alleged to be entered and sanctioned by the then Honble Court of Assistant Collector, Phagwara, District Kapurthalla, alleged to be passed on the basis of alleged Will dated 18/08/1999 alleged to be executed by Sh. Gurbakhsh Singh son of Sh. Ganda Singh son of Sh. With the consequential relief of permanent injunction restraining the defendants no.1 and 2 from alienating, selling, disposing off, transferring, mortgaging, gifting or creating any kind of charge etc. upon the property in question and further restraining the defendants no.1 and 2 from interfering into the peaceful possession of the plaintiff thereby dispossessing the plaintiff from the property in question or handing over the possession of the property in question to anyone as fully detailed above, illegally, forcibly or through any other way, forever.


Whereas it has been proved to the satisfaction of the Court that the defendant(s)/respondent(s) above named cannot be served in the ordinary way of service. Hence,
