Sub:- Reimbursement of mobile/landline/broadband usages to District & Sessions Judges and Judges of Subordinate Courts of Punjab, Haryana and U.T., Chandigarh.

Sir,

I am directed to refer you on the subject cited above and to inform you that Hon`ble the Chief Justice and Judges have been pleased to revise the Policy of reimbursement of mobile/landline/broadband usages to Judicial Officers, which is as follows:-

“At present, a Judicial Officer is entitled to following reimbursement:-

Sr. No.	Designation	Admissible Plan	
		Mobile	Landline / Broadband
1.	Superior Judicial Service	₹1000/-plus ₹200/- (rental package)	₹1425/- (BB Combo-ULD Plan) or any other equivalent plan of any other service provider.
2.	Other Judicial Officers	₹750/-plus ₹200/- (rental package)	

In order to clarify the matter, it is recommended that now, the Judicial Officers will be entitled to reimbursement as under:-

Sr. No.	Designation	Admissible Plan	
		Mobile	Landline / Broadband
1.	Superior Judicial Service	Any family pack/home pack or any other pack facility (more than one connection) subject to the upper limit of ₹1400/- (inclusive all taxes) excluding pre paid mobile connections.	Any family pack/home pack or any other pack facility for landline/broadband fiber connections and payment of advance rental package on landline/broadband of any service provider subject to the upper limit of ₹1500/- per month (inclusive all taxes).
2.	Other Judicial Officers	Any family pack/home pack or any other pack facility (more than one connection) subject to the upper limit of ₹1000/- (inclusive all taxes) excluding pre-paid mobile connections.	

In case, anyone opts for combined package of mobile and broadband of any service provider (e.g.Airtel Black/Jio Fibre/VI etc.), the reimbursement will be permissible upto the combined prescribed limit.

All the reimbursement of pre-paid broadband fiber connection(s), shall be admissible after expiry of period of the plan/package.”
